

#### 4th Annual International Course

## Qualitative Methods for Health and Social Care Research

## Course objectives:

This course is organized by the Institute for Research & Development in collaboration with Institute of Public Health at the University of Cambridge UK, Research Institute for Primary Care & Health Sciences, Keele University UK, Institute of Psychiatry at King's College London UK, South Asian Hub for Advocacy, Research & Education on Mental Health (SHARE), and Faculty of Medical Science, Anglia Ruskin University UK, as part of global research capacity building initiative for researchers.

Following the successful courses conducted in 2012, 2013 and 2014, the course will be held for the fourth time in 2016 as an annual event for researchers from Sri Lanka, the wider South Asian region, and any other part of the world, to gain theoretical knowledge and practical training in qualitative research methods. The previous courses hosted more than 25 participants in each intake including medical professionals, allied health professionals, NGO workers, and other health and social care researchers.

## Course participants:

The course is suitable for all levels of health and social care researchers interested in conducting qualitative research but lacking adequate theoretical knowledge and practical training in the subject. However, people from other disciplines (Medicine, Anthropology, Biology, Education and more) are also encouraged to take part in the course to further their skills on how to work in a multi-disciplinary research environment, and share their experiences.

Main expected course outcomes for participants include: ability to develop qualitative research proposals for funding applications, involvement of peer-review process through post-course support groups, receiving hands-on experience of qualitative research design and analysis, and contributing to capacity building in their respective organizations using the knowledge gained from the course.
